TOURNAMENT CONDITIONS

1. Competitors must be in good standing with their National Association and since 1st August, 2011, have been playing members of clubs affiliated to Badminton England. Competitors, at the date on which entries close, must be qualified by the Regulations of the County Championships to represent Lancashire
2. The Committee reserves the right to refuse any entry without assigning a reason, to limit the entries for any event and to alter or modify the programme in any way it sees fit. Its decision on all matters shall be final.
3. Entries on the official form shall reach the Honorary Championships Secretary, with entry fees and stamped self-addressed envelope, or Email address by **Saturday, 10th September, 2011**. If the Committee should accept entries and/or fees after this date there will be a MANDATORY SURCHARGE of £5.00 per person. Each competitor must send a separate entry form. All claims for refunds must be in writing to the Honorary Referee to arrive not later than 1 day after the date of the tournament. The Committee reserves the right to refuse refunds if insufficient notice or reason is given. A £5 Administration fee will be deducted from any refund given.

POs or Cheques should be made payable to L.C.B.A. Entries will not be accepted or placed in the draw without the appropriate entry fee having been paid.

Competitors requiring a partner should enter 'partner wanted' in the 'Partners Name' column of the entry form.

4. Competitors must be prepared to play at the times stated for the commencement of each event. If a later time is stated in the appropriate column of the entry form, the Committee will consider this, but no guarantee can be given. Competitors will be advised by Email or post of the time that they are required for their first match in each event for which their entry has been accepted. If no such notification has been received by Tuesday, 27th September, 2011, it is the responsibility of the competitor to inquire from the Honorary Referee, Mrs Elaine Clough (Tele 01704 896680 OR Mobile 07852 340458) the times of their events.

ANY COMPETITOR NOT READY TO PLAY WHEN CALLED UPON WILL BE LIABLE TO BE SCRATCHED.

Competitors must report to the referee immediately upon arrival, before changing, and must not leave the hall without the Referee's permission until eliminated from all events.

Play shall not take place on days other than those sanctioned and no competitor shall be obliged to commence a match before 9 am or after 11 pm on any such day. Any competitor who is not prepared to play outside these times of play shall be entitled to a refund of the entry fee.

The period for knocking up before any match shall not exceed Three minutes.

5. The Championships are promoted by the Lancashire County Badminton Association and are subject to the Regulations for Tournaments of Badminton England. Normal Clothing Regulations will apply.
6. The draw will be seeded, feathered shuttlecocks will be used. The Rally Points Scoring system will be used.
7. Drug testing: Sport England has introduced random drug testing. A Sport England Official may attend this tournament and carry out tests on any competitor. Any competitor found to have taken banned substances, or refusing to take a test, will be disqualified from the tournament, reported to Badminton England and any prize won shall be returned to the Tournament Referee. Parental consent is necessary for U18s. A declaration appears on the entry form. Entries without this consent cannot be accepted.
8. All trophies are perpetual and may not be taken out of the care of the Lancashire County Badminton Association.
9. Prizes will be presented as follows:
Singles events: Winner £30.00; Defeated Finalist £15.00
Doubles events: Winners £40.00 per pair; Defeated Finalist £20.00 per pair
10. All competitors must be prepared to act as line judges, if so required.

11. PENALTIES. The following penalty system will apply:

	Maximum Penalty
i. Failure to arrive without notification	£100
ii. Failure to arrive with notification within a reasonable period but without proper reason	£50
iii. Late arrival on court without proper reason	£20

NOTE A player who has been penalised has the right of appeal.

- i. All appeals must be in writing to Badminton England and made within one month of the close of the tournament.
- ii. From the time that the draw for the tournament is made all communications between players and the Tournament Committee MUST BE WITH THE REFEREE, where withdrawal, late arrival, etc are concerned.
